RECENT EVENTS AFFECTING OUR CLIENTS

Among the developments we have tracked since the beginning of 2022, all of which have substantial implications for our corporate client base and others:

- US. Groundbreaking actions by federal departments/agencies to regulate PFAS/PFOS chemicals, including EPA's proposal to list them as "hazardous substances" under Superfund; SEC's proposal to mandate climate disclosures by public companies; Department of Justice receipt of funding to advance environmental justice and address the impacts of climate change;
- Europe. Commission, DG Environment announcement of upcoming Public Consultation concerning the EU Environmental Liability Directive; Commission's Draft Directive to require corporate human rights and environmental reporting;
- **Brazil**. Review by the Brazilian Supreme Court for the first time on challenges against the Government for climate change related issues;
- Australia. Legal ruling found the government does not have a duty of care to mitigate climate harm when considering approval of a mine expansion;
- **United Kingdom**. Consultation launched seeking public input on actions to protect people and environment from climate change and biodiversity loss.
